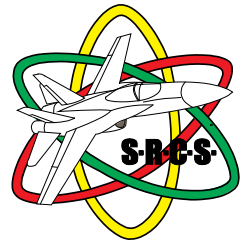

Please ensure your MAAA AUS XXXX number is entered as the reference for the transfer so I can identify who the payment is from. If I cannot work out who has sent the money, the membership application will not be processed until I am satisfied that the money is for that person.

All members who have registered to receive email from the club will be sent an electronic version of the membership renewal form. Once you have made the electronic transfer then please immediately complete this form on your computer and email it to the treasurer, please do not email the form to any other committee member.

If for some reason you are unable to complete the form electronically then you can please print it and post it or give it to the treasurer at the field or email it to the treasurer ensuring payment has been sent.

4. 2017/2018 SRCS Associate membership is accepted only with proof of current MAAA membership for 2017/2018. No other option other than MAAA membership is accepted.
